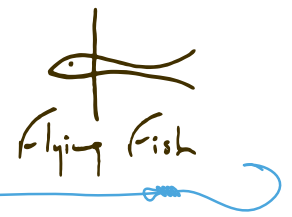

Terms and conditions

Booking confirmation

Bookings are confirmed once we receive a completed, signed Group Booking Form and your deposit.

Cakes

Our pastry kitchen is happy to prepare a cake for your special occasion. Please speak to your event manager about choices.

Cancellations

Any cancellation must be made in writing to Flying Fish. Cancellations made under 14 days notice will result in a forfeit of 50% of the deposit paid.

Cleared funds

Bank cheques or personal cheques payable to 'Taste the View P/L' will be accepted as payment for events where the funds are cleared 14 days prior to the date of the event.

Deposits

To secure a booking, a deposit of \$1,000 is payable.

Final payment is then payable, including beverages on consumption at the completion of your meal. We will provide you with a detailed tax invoice less the deposit paid.

Final numbers

Final numbers for group bookings must be confirmed **48 hours** prior otherwise a cancellation fee of \$50 per cancelled guest will apply.

GST

Prices are inclusive of GST.

Merchant fee

A merchant fee of 1.5% of the total amount payable applies on all Visa, Mastercard, American Express and Diners Card payments.

Wine selections

Wine selections must be confirmed prior to the date of your booking and we are more than happy to assist you with your selection. Please see our Events Menu for a suggested wine selection. Alternatively, a more comprehensive wine menu is available on request.

Other conditions

- Flying Fish Restaurant is committed to the Responsible Service of Alcohol. Intoxicated guests will not be served. It is a requirement of law that intoxicated persons are removed from licensed premises.
- With the exception of Kosher meals, no outside catering or beverages are permitted within Flying Fish.
- Flying Fish reserves the right to change prices, menus and ingredients at any time by notice to the client.
- Any damage to the restaurant, its property or staff caused by the client, its guests and invitees will be charged to the final account and be made payable by the client.
- Flowers and cakes can be organised at your request with at least 3 days prior notice.
- The client is expected to conduct their function in a legal and respectable manner and is responsible for the conduct of its guests and invitees. Please also note that in line with Australian legislation relating to responsible service of alcohol, Flying Fish Restaurant staff and management reserve the right to terminate a function, refuse service to any guest deemed intoxicated, or take responsible action to assist any intoxicated guest from the premises.
- Flying Fish is licensed to serve alcohol until Midnight only.

Parking

Flying Fish has valet parking available. Cost is \$25 per car flat rate. Please note additional valet fees apply if your vehicle is required to remain on the wharf overnight. Alternatively metered street parking is available on Pirrama Road or undercover parking at Wilson Promontory across from Jones Bay Wharf.

Public holiday surcharge

An additional 10% food & beverage surcharge is applicable for all days gazetted by the Government as a public holiday.

Service charge

An 8% service charge applies to all group bookings at Flying Fish and will be added to the final tax invoice.
